



Motor Home Parking Site Rules

Berghamer Straße 1 | 84489 Burghausen | Germany

(1) Opening times:

Site open all year round; The barbecue area is closed at the moment.

(2) Conditions of use:

The marked parking site is available for use by motor homes (registration certificate II = "special vehicle: motor home"). Caravans (including trailers, passenger cars, motorbikes, coaches, sales trailers) and tents are not permitted on the site. Camping equipment (awnings etc.) is not permitted. Car parking spaces can be found in front of the site.

Burghauser Touristik GmbH shall be solely responsible for deciding on exceptions to these rules.

(3) Registration, period of use, fees:

Maximum period of use: 7 nights; site fee: EUR 10.00 per night.

There is a ticket machine on the site that can be used to pay the site fee (coins only). Visitors staying for more than one night should pay the fee for the next night by no later than 10 a.m. The ticket should be clearly visible through the windscreen of the motor home.

Registration and key handover (deposit of EUR 50.00) for the use of the sanitary facilities in the building by the barbecue area (washing-up room, WC, showers) should be arranged via: Bürgerhaus Burghausen, Marktler Str. 15 a, 84489 Burghausen, Germany; tel. +49 8677/97400, Monday to Friday 9 a.m.-12 p.m. and 2 p.m.-5 p.m., Saturday, 9 a.m.-1 p.m.; At other times: registration via Café Plan B (same address), Monday to Thursday 11 a.m.-10 p.m., Sunday 9 a.m.-9 p.m.

(4) Facilities:

18 motor home parking bays.

2 power columns each with 4 connections for power supply (230 V CEE power socket). Coin-operated; EUR 0.50 per kWh of electricity.

1 Holiday Clean for waste water and fresh water. Coin-operated; EUR 1.00 for approx. 70-80 litres. Sanitary facilities in the building by the barbecue area across the road with 3 WCs (ladies, gentlemen, disabled) and 2 showers (coin-operated), washing-up room.

Paved parking bay access; gravelled parking bays.

There are no facilities for waste disposal!

- (5) The user shall be liable to the City for any damage to property or personal injury caused as a result of the use of the site. The user shall indemnify the City from and against any third-party claims for damages arising as a result of the use of the site. The user shall waive all liability claims against the City and, in the event of recourse proceedings, shall waive the assertion of rights of recourse against the City.
- (6) Open fires, barbecues etc. are not permitted on the parking site. The barbecue area can be hired on request (for a fee; see the signage at the barbecue area). Please comply with the nightly quiet time from 10 p.m. to 7 a.m.
- (7) Users should show consideration to other residents of the site and users of the barbecue area. Care should be taken to ensure that no noise pollution is caused when leaving the motor home parking area and on arrival and departure. Dogs are to be kept on the leash on the motor home parking site at all times.
- (8) The site must be left in a clean and tidy condition after use. Users must take any rubbish away with them.
- (9) The house rules for the motor home parking site are enforced by the City of Burghausen and the inspectors working on its behalf. Under the Act on State Penal Law and Decree Law, any contraventions of these rules or a failure to pay the daily fee may be punishable by a fine. Users may also be banned from the site. No claims for damages or compensation shall be permitted in this case.
